REQUEST FOR BID

The Cloudcroft Board of Education will accept bids for furnishing propane fuel for heating school buildings. Service will be for the 2024-2025 school year, beginning August 1, 2024 and ending July 31, 2025. School year consumption is approximately 60,000 gallons. Please quote per gallon delivered price.

Trucks must be equipped with numbered printing meters, all tickets must show this meter stamp.

Tanks at the elementary/middle school and the high school are owned by the school. Tanks are to be filled without owner notifying supplier of need. Failure to do this would be reason to void the contract. Fuel is to be delivered at the two (2) locations approximately ¼ mile apart.

Fuel must be pure propane. Butane or butane mixture will not be accepted.

Maintenance on tanks, lines, vaporizers, boilers, and gas appliances to be furnished by supplier. All repair parts are to be furnished at the dealer's cost. Charges, if any, for maintenance must be stated in the bid proposal.

Supplier must notify, by documentation from refinery, changes in bid price prior to delivery.

Supplier must pressure test all L.P.G. installations at least once at the beginning of the school year and at other times deemed necessary by the school administration and the supplier. Each pressure test must be certified in writing to the Superintendent of Schools.

SUBMISSION OF BIDS

Bids must be received in the office of the Superintendent of Schools, P.O. Box 198, #10 Swallow Place, Cloudcroft, NM 88317, by **11:00 am on Thursday, July 25, 2024**. Bids will be opened at 11:30 am on Thursday, July 25, 2024. Bids must be sealed in an opaque envelope plainly marked on the outside "PROPANE BID FOR 2024-2025". Bids must be submitted on the enclosed bid form.

AWARD OF BID

Bids will be awarded to the bidder which, in the opinion of the school, satisfactorily meets the specifications and demonstrates the ability to perform the required services. Pricing packages and/or guarantees that will benefit the school district will be considered in the evaluation of the bids. The school reserves the right to accept or reject any portion or all of any bid and to waive any or all technicalities.
